



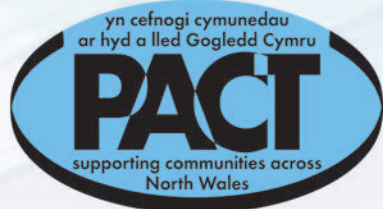

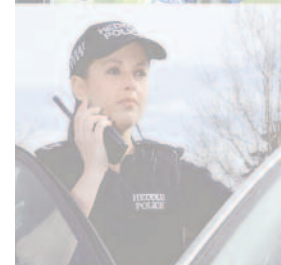

Trustees Annual Report

The Trustees have pleasure in presenting their report and the financial statements of the charity for the twelve month period ended 31st March 2012.

Objectives

The Trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Trust's aims and objectives and in planning future activities and setting the grant making policy for the year. In all activities the Trust seeks to raise the profile of Community Safety and, through the protection of people and property, significantly minimise the fear of crime thereby enhancing quality of life throughout the region. The activities include:

- Promoting crime prevention initiatives.
- Promoting Road Safety as an integral part of life to the people of North Wales through training, education, publicity, and special projects.
- Educating the people of North Wales in all matters relating to drug, alcohol and other substance abuse thereby helping to reduce drug-related crime.

Constitution

The North Wales Police and Community Trust was launched on 14th October 1998. The trust is a registered charity under the Charities Act 1993. The Charity registration number is 1071628.

Governing Documents

The Trust is governed by the Declaration of Trust (Trust Deed), which was formally made on 9th September 1998.

Organisation of the Charity

The Trust is run by the Board of Trustees. In accordance with the Declaration of Trust, the Board of Trustees, when complete, should consist of up to thirteen Trustees representing North Wales Police, North Wales Police Authority, the business sector, and the High Sheriffs of Clwyd and Gwynedd.

Restrictions of the Trust's Activities

The activities of the Trust are restricted to the objectives as outlined in the Declaration of Trust as approved by the Charities Commissioners. The area that can benefit from the Trust's activities is restricted to North Wales.

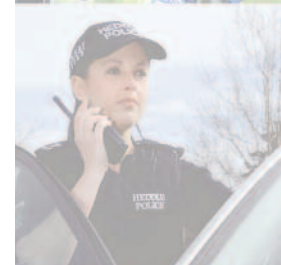
Policy on Reserves

The Trustees are aware of the Charity Commissioners requirement in regard to Reserves policy.

The Trustees regularly review the level of reserves held by the Trust, and are satisfied that these are kept at an acceptable level to ensure that the Trust continues to operate effectively.

Independent Examination

In accordance with PACT's original Declaration of Trust the trustees confirm that, as the Trust's annual turnover is less than £250,000 an Independent Examination is required.



Review of Activities - Year Ending 31st March 2012

PACTS Charitable Objectives:

- Promotion of an enhanced quality of life through the prevention and reduction of crime and the fear of crime and the protection of people and property from criminal activity.
- Promote education of drug and alcohol abuse to reduce crime.
- Promote road safety as an integral part of life of the communities of North Wales.

The Board of Trustees is committed to supporting these objectives, and this is reflected in the ongoing development of PACT. Throughout the past twelve months the Trustees have continued to work closely with North Wales Police to ensure that the Trust develops projects that support policing priorities, and reduce crime and anti-social behaviour issues which have a detrimental impact on our communities.

This year has been particularly successful in terms of funding and project development, and the year concluded with the exciting delivery of our Justice in a Day initiative to 800 young people in north Wales.

This success will enable PACT to continue with its development of new and existing projects which are featured in this report.

PACT with 800 young people across north Wales “Justice in a Day”

This year, in partnership with Clwyd Theatr Cymru, PACT delivered a highly successful five week programme of interactive drama workshops aimed at showing young people the consequences of crime, called - “Justice in a Day” which is focussed on preventing young people from engaging in criminal activities.

The workshops, which ran during February and March 2012 investigated youth-on-youth assault as a result of malicious cyber and text bullying.



Led by Emyr John, a Drama Outreach Worker at Clwyd Theatr Cymru, the workshop follows a character called Alex from the time before he committed a crime, to his trial, imprisonment and the consequences for his family, friends and the victim. It was performed by professional actors Richard Shackley and Claire Barron.

The project reached 800 Year 9 students (age 13-14) from 50 Secondary Schools representing every county in north Wales in a series of interactive workshops that investigated the causes and consequences of the above issues on the offender, the victim, their families and the wider community.

The interactive nature of the project enabled young people to be involved in a frank, honest and open investigation into the consequences of criminal actions. Each school spent a full day in the specially created workshops, which included a Court session with a Magistrate discussing sentencing and its impact.

Justice in a Day was made possible by sponsorship from Comtek Network Systems Ltd, Magnox, Thomas Howell's Education Fund, North Wales Fire and Rescue Service, a donor from the Wrexham area, together with support from North Wales Police School Community Police Officers, University Glyndwr, north Wales Magistrates, and HM Courts.

The workshops were thoroughly enjoyed by the students and judging by their participation were clearly understood as well. We are aiming to repeat this years success expanding the workshops throughout the region in 2013, and ultimately seeing Justice in a Day become an annual event in the school calendar.

Review of Activities - Year Ending 31st March 2012

Amongst the feedback that we have received from schools:

Gary Sugrue, Deputy Head of Blessed Edward John Catholic High School, Rhyl said “A brilliant, thought provoking day. The workshops, acting and interaction with the students were excellent. I am certain that all our students and teachers will have learnt a lot during the day.”

Gareth Jones, Headteacher, Ysgol Botwnnog added “A very informative workshop. Pupils self-esteem has increased following the day and has made them think about the law, and the consequences of personal choices.”

Police Property Act Fund

This year PACT has managed £36,000 on behalf of North Wales Police Authority which has enabled the Trustees to support 10 projects with funding of £9,343 in addition to supporting Neighbourhood Policing Teams with grants totalling £9,583 through our Small Grant Fund.

These projects have included:

- Bangor Street Pastors
- Tackling Drugs Football initiative in Conwy
- Conwy and Denbighshire Bus Stop young people’s outreach education programme
- Anglesey No Cold Calling Zones
- Woodlands Watch Scheme
- Victim Support

- Young people’s road safety education programme
- Point FM, Rhyl - community radio engagement
- Llangollen Community Safety Group to support their Business Watch scheme
- Over 200 Small Grants made during the year to Neighbourhood Policing Teams across north Wales.

Many of the above projects have received coverage in the local media following articles appearing on the PACT and North Wales Police websites.

Once again we have found that the management of the Police Property Act Fund has enabled PACT to leverage funding from other sources, in particular £8,500 for our Justice in a Day programme and also funding of £21,000 for Operation B.A.N.G. and the Easter Grant Campaigns.

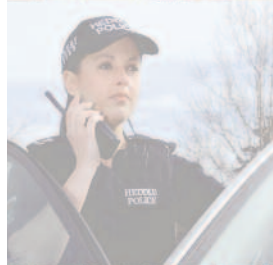
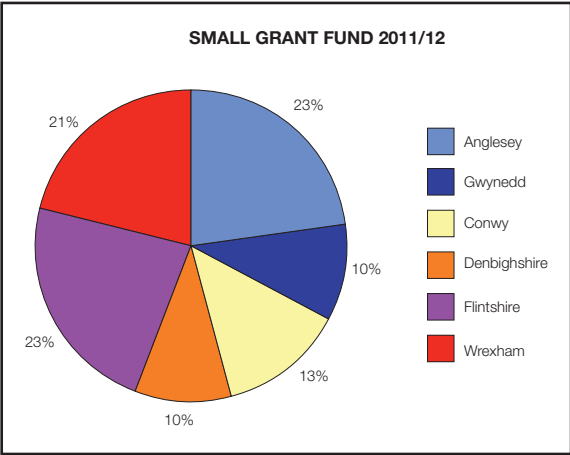
The Trustees of PACT are enormously grateful to the North Wales Police Authority for their continuing support.

Neighbourhood Police Teams Small Grant Fund

The Small Grant Fund continues to be extremely popular with Neighbourhood Policing Teams and has proved to be a valuable tool to help them support local community groups. 40 small grant applications have been supported this year totalling in excess of £9,500.

As in previous years our aim with this funding stream is to provide Neighbourhood Policing Teams across north Wales with an effective way to support community engagement initiatives, with relatively small amounts of funding (up to £250), through a simple application process.

The chart gives an indication of the geographical spread of this year’s Grants (based on £value of Grants). Year-on-year comparison shows that activity in Denbighshire and Gwynedd has dropped slightly from 2010/11, and we hope that this will be area for development during 2012/13.



Review of Activities - Year Ending 31st March 2012

Operation B.A.N.G. (Be A Nice Guy) 2011

This will be the third year that PACT has worked with the North Wales Arson Reduction Team (a joint initiative between North Wales Police and North Wales Fire & Rescue Service) to secure and manage funding to support community initiatives during the Halloween and Bonfire Night periods.

This funding programme continues to be extremely popular with members of Neighbourhood Policing Teams. This is reflected in the funding that PACT has secured, which has increased each year, from £ 6,000 in 2009/10; £10,000 in 2010/11, and £14,000 during this year

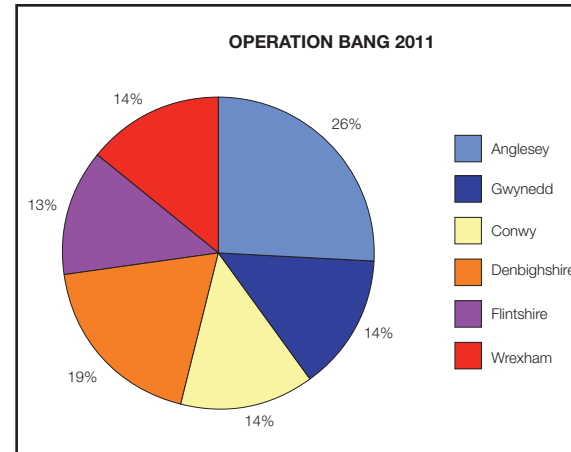
Many of this year's initiatives incorporated firework and bonfire safety education into local activities with young people highlighting specific themes including:-

- Health and Safety related to the risks associated with fireworks and bonfires.
- Road Safety in relation to the increased risks of accidents involving young pedestrians wearing dark clothing on poorly lit streets.
- Anti social behaviour in the context of 'Trick or Treating' with particular emphasis on respect for elderly residents who may not wish to receive callers at their home.

- Personal Safety, particularly in relation to the increased risk associated with children entering the homes of strangers whilst engaged in 'Trick or Treat' activities.

Kevin Jones Arson Reduction Manager said "The team are pleased to be working in partnership with PACT, the project has enabled the Arson Reduction Team form closer working relationships with Neighbourhood Policing Teams to reduce deliberate fire setting, anti-social behaviour and associated crimes".

81 grants totalling £15,126 were made which are broken down by county on a £value basis as follows:



Easter Small Grant Campaign 2012

This year we launched our first Easter Small Grant Campaign, designed, in partnership with the Arson Reduction Team, to address anti-social behaviour issues during the Easter holiday period.

Neighbourhood Policing Teams were able to apply for grants of up to £200.00 that supported their engagement with young people, and provided diversionary activities such as outdoor pursuits and organised events that were carried out at times which, historically, have seen increased incidents of anti-social behaviour.

To qualify applicants had to demonstrate one of the following problems:-

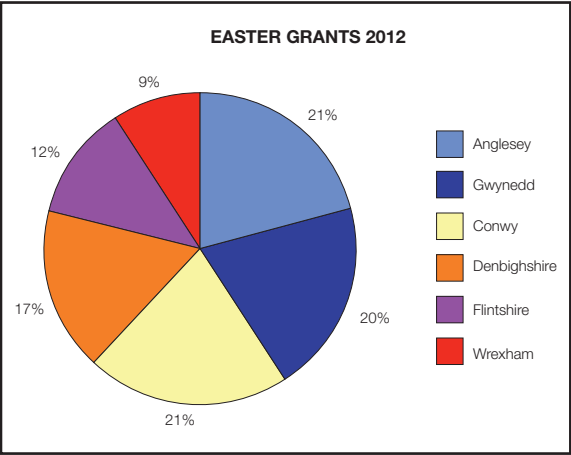
- Deliberate fires, specifically countryside fires
- Antisocial Behaviour
- Criminal Damage
- Or an initiative that addressed an emerging problem

Many applicants took the opportunity to incorporate education workshops into their initiatives. These varied from workshops on the dangers of under-age drinking and drug mis-use, to team building activities at local schools, and community litter-picks with youth clubs.

Review of Activities - Year Ending 31st March 2012

Sergeant Melanie Brace, Arson Reduction Team said “This is the first time we have run this project at Easter, and follows another successful BANG project. The Arson Reduction Team will continue to work in partnership with PACT to facilitate a further Easter Campaign in March 2013, building on the success of the first year. We will continue to encourage Neighbourhood Policing teams to incorporate an element of fire safety education to the application process to compliment the fire safety message issued by the Fire & Rescue Service”.

44 grants totalling £8,025 were made which are broken down by county on a £value basis as follows:



The High Sheriff's Crimebeat Fund

Crimebeat encourages young people to develop a project in their community that will help to prevent crime, reduce crime and improve their community.

The objectives of the fund are:

- To keep young people out of trouble
- To support victims of crime
- To stimulate an interest in voluntary work
- To strengthen local communities
- To improve behaviour and school attendance.

During the past year the High Sheriffs of Clwyd and Gwynedd have, for a second year running, raised over £17,000 to enable young people to develop local community projects with over £13,000 being invested in 38 young people's projects across north Wales.

The Annual Crimebeat Awards continue to highlight the best of these projects, and the Award ceremonies give the High Sheriffs of Gwynedd and Clwyd the opportunity to recognise the work of young people who are doing positive work in their communities.

This year's ceremonies were held at the David Hughes Community Centre, Beaumaris and Yale College, Wrexham where over 160 invited guests saw a number of young people's groups being recognised, including:

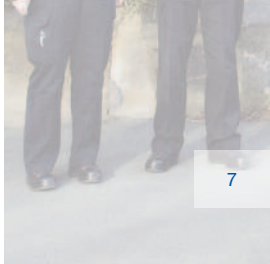
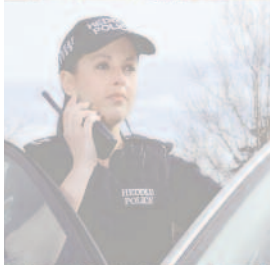
- Digatref Ynys Môn - Prevention is Better Than Cure
- Valley Community Pride
- Ysgol Uwchradd Tywyn
- Llandudno Youth Club - "Say No" project
- Saltney Youth Council
- Denbigh Youth Project
- Brynteg Primary School - Playground Pals anti-bullying scheme

The overall winners were:

Gwynedd Crimebeat - Digatref Ynys Môn, "Prevention is Better Than Cure" which worked with young homeless people on Anglesey looking at addressing the links between homelessness and crime. The initiative also included a hard-hitting and thought-provoking visit to Altcourse Prison.

Clwyd Crimebeat - Llandudno Youth Club "Say No" project. Young people from the youth club in Llandudno and surrounding area worked with a professional musician/DJ to write and record rap songs that discouraged young people from under-age drinking, drug use, and anti-social behaviour.

2012 will see Crimebeat celebrate its 10th Anniversary in north Wales and there are already a number of events being organised to highlight this achievement.



Review of Activities - Year Ending 31st March 2011

The High Sheriff of Gwynedd - Round Anglesey Walk

The High Sheriff of Anglesey and Gwynedd, Professor Robin Grove-White, walked the entire 125-mile Anglesey Coastal Footpath on 15 consecutive days between 17th and 31st March 2012 to raise funds for Crimebnerat which will be invested in youth initiatives in Anglesey, particularly those which support vulnerable young people.

More than 600 individuals and groups joined him, and his wife Helen, at various stages of 'The Walk', over the last two weeks of March. These included Albert Owen MP, Ieuan Wyn Jones AM, several Judges, supporters, friends, numerous voluntary organisations and groups of unemployed young people.

The Walk raised over £16,000.



Conclusion

In our Annual Report for 2011 we spoke about the opportunities that the Justice in a Day project could bring.

2012 has already seen a number of these opportunities being realised, and the Trustees strategy of developing our own unique brand has seen PACT secure funding in excess of £53,000 during this year to support Justice in a Day.

When this is combined with project reserves already held, and monies pledged/confirmed for 2012/13 to support Justice in a Day, the Trust is now on track, not only to deliver this project again, but also to becoming self-sustaining, thereby reducing the level of in-kind support needed from the Police Authority in the coming years.

It has become clear whilst delivering Justice in a Day that there is a need and a demand for the project from schools and the fact that we have reached 800 young people this year is testament to that demand. The Trustees consider that, moving forward, Justice in a Day has the potential to become a recognised part of the school curriculum in north Wales.

The Trustees are committed to ensure that PACTs work supports North Wales Police policing priorities and to this end the Justice in a Day workshops, which are designed to educate young people about the consequences of crime, are focussed on putting prevention of crime first.

This priority is also key to attracting financial support from external sources, particularly the business sector, which has been the key to our success this year.

Our work with Neighbourhood Policing Teams is also designed to support Policing Priorities and support them in their work at the grass-roots of our communities. This is evidenced by the consistent demand for funding local initiatives through the Small Grant Fund.

The Trustees, and the High Sheriffs of Gwynedd and Clwyd, would once again wish to express their thanks to the members of the Police Authority for their continued support and involvement with PACT during the course of the past twelve months, and look forward to further successes and partnerships over the coming year.



Statement of Trustees' Responsibilities

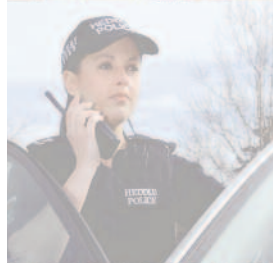

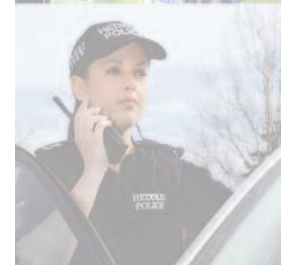

Notes to the Accounts

1. Accounting Policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and in the preceding year.

a) Basis of Accounting

The accounts are drawn up on an accruals basis and in accordance with the Statement of Recommended Practice: Accounting and Reporting by Charities issued in March 2005.

b) Fund Accounting

- Unrestricted Funds are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity.
- Restricted Funds are subject to restrictions on their expenditure imposed by the donor.

c) Incoming resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

- Voluntary income is received by way of grants, donations and gifts and is included in full in

the Statement of Financial Activities when receivable. Grants, where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.

- Donated services and facilities are included at the value to the charity where this can be quantified.
- Investment income is included when receivable.
- Incoming resources from grants, where related to performance and specific deliverables, are accounted for as the charity earns the right to consideration by its performance.

d) Resources expended

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates:

- Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

- Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include the independent examination fees and costs linked to the strategic management of the charity.
- All costs are allocated between the expenditure categories of the SoFA on a basis designed to reflect the use of the resource. Costs relating to a particular activity are allocated directly, others are apportioned on an appropriate basis e.g. floor area.

2. Employees Remuneration

No employees were paid by the trust during the period. The services of a Project Manager/ Crimebeat Co-ordinator were donated by North Wales Police. This cost is included in the statement of financial activities.

3. Trustees Remuneration and Expenses

None of the Trustees, nor any connected persons, received any remuneration during the period.

No reimbursement of Trustees expenses, or any other connected persons, was made during the period.

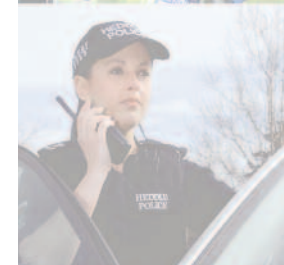

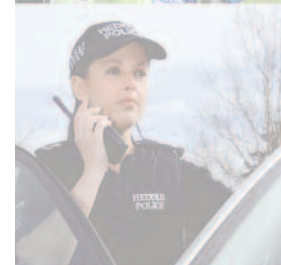

- **Clwyd and Gwynedd Crimebeat:** funds are used to provide grants to young people aged 5 to 25 to develop good citizenship, crime prevention initiatives that raise awareness of community safety issues.
- **Arson Reduction Grant:** represents funding for Neighbourhood Policing Teams to engage with young people, and funding to support diversionary activities and initiatives around Halloween and Bonfire Night 2011.

- to prepare accounts which accord with the accounting records and to comply with the accounting requirements of the 1993 Act

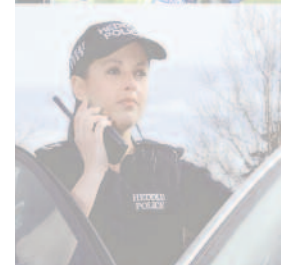
