Chairman's Report

Despite the on-going lockdowns and restrictions 2021/22 saw PACT continue to support community groups across North Wales with 120 projects funded during the year, many of which have featured in local press and social media. Examples include Ogwen Valley Mountain Rescue, Coedpoeth Phoenix Youth Football Club and Friends of the Cob in Rhyl which was also featured on ITV Wales News for its work to support isolated and vulnerable young people and adults. You can find a list of all projects/organisations funded in the appendix.

We have also been able to support community groups including Friends of Barmouth Park, North Wales African Society, Môn SAR, Friends of Queen's Park Llandudno and the young people of Rhyl Raptors Wheelchair Basketball Club, together with a variety of projects that not only support our charitable objectives but also improve the lives of local residents and encourage engagement with local policing teams.

With the on-going support of the Police Property Act Fund together with match-funding received from CGI UK Ltd we were also able to continue to support Neighbourhood Policing Teams with our Small Grant Fund and saw a 67% increase in the number of small grants made compared to 2020/21. We will continue to focus on our work with Neighbourhood Policing Teams through this ever-popular fund and aim to see continued growth in grant numbers.

The High Sheriffs Crimebeat Youth Fund has continued to support young people's initiatives and whilst lower in numbers than in pre-covid times Crimebeat has been able to support projects in Queensferry, Colwyn Bay, Wrexham, Bangor, Bethesda, Dyffryn Nantlle amongst others. I am grateful to both High Sheriffs, Steve Thomas in Clwyd, and Gwyn Owen in Gwynedd, for all their hard work during the year.

A highlight of the year was the successful North Wales Primary School Internet safety Poster Competition which saw over 570 pupils submit entries.



With sponsorship from Crimebeat, PACT and CGI UK Ltd six winning schools across Central, Eastern and Western Areas received financial awards to support their work on internet safety and the winning pupils each received prizes donated by businesses across North Wales. Our overall winner, Eva Lloyd Wright from Ysgol Edern in Gwynedd, was also featured on S4C children's TV programme 'Ffeil'. We are aiming to repeat the success of this competition again in 2022/23.

The High Sheriffs Crimebeat fund also continued the High Sheriffs Cadet Challenge in 2022. First launched in 2021, this year saw Volunteer Police Cadet Oliver Heath Lloyd-Greenall take first place with his proposal to address anti-social behaviour in Ruabon which is now being developed to go 'live' with the local Neighbourhood Policing Team.

2022 saw the ninth year of 'Your Community Your Choice' with 21 successful groups receiving funding. 'Your Community Your Choice' continues to be a hugely popular fund which this year again saw £58,750 being made available to local community initiatives with the general public deciding which groups receive funding through a public vote.

Many of these have already featured in local press having been visited by the Police and Crime Commissioner. Projects supported this year included DangerPoint's knife crime project; Youth Shedz with a project to educate young people about County Lines; North Wales Women's Centre; regeneration of a community garden in Cwm Cadnant on Anglesey; Gisda's LGBTQ+ youth club; the Forget-Me-Not Chorus in Abergele working with those living with dementia; and Buckley Boxing Club and many others.

Once again 'Your Community Your Choice' was funded equally between the Commissioner's Fund and monies recovered from criminals under the Proceeds of Crime Act.

Finally, I would like to thank my fellow trustees, the Chief Constable, the Police and Crime Commissioner and officers and staff of North Wales Police for their continued support for our work.

I hope you will enjoy reading this latest Annual Report.

Trustees Annual Report

The Trustees have pleasure in presenting their report and the financial statements of the charity for the year ended 31st March 2022.

Objectives

The Trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Trust's aims and objectives and in planning future activities and setting the grant making policy for the year. In all activities the Trust seeks to raise the profile of community safety and, through the protection of people and property, significantly minimise the fear of crime, thereby enhancing quality of life throughout the region. The activities include:

- Promoting crime prevention initiatives.
- Promoting Road Safety as an integral part of life to the people of North Wales through training, education, publicity, and special projects.
- Educating the people of North Wales in all matters relating to drug, alcohol and other substance abuse, thereby helping to reduce drug-related crime.
- Developing educational programmes for the benefit of young people and others.

Constitution

The North Wales Police and Community Trust was launched on 14th October 1998. The trust is a registered charity under the Charities Act 1993. The Charity registration number is 1071628.

Governing Documents

The Trust is governed by the Declaration of Trust (Trust Deed), which was formally made on 9th September 1998.

Organisation of the Charity

The Trust is run by the Board of Trustees. In accordance with the Declaration of Trust, the Board of Trustees, when complete, should consist of up to thirteen trustees representing North Wales Police, North Wales Police Authority, the business sector, and the High Sheriffs of Clwyd and Gwynedd.

Restrictions on the Trust's activities

The activities of the Trust are restricted to the objectives as outlined in the Declaration of Trust as approved by the Charity Commission. The area that can benefit from the Trust's activities is restricted to North Wales.

Policy on Reserves

The Trustees are aware of the Charity Commission's requirement in regard to reserves policy. The Trustees regularly review the level of reserves held by the Trust, and are satisfied that these are kept at an acceptable level to ensure that the Trust continues to operate effectively.

Independent Examination

In accordance with PACT's original Declaration of Trust the trustees confirm that, as the Trust's annual turnover is less than £500,000, an independent examination is required. Should the Trust's turnover exceed this level then a full audit will be required.

In all its activities PACT strives to support the objectives of the Police and Crime Plan, reducing crime and anti-social behaviour and helping to make North Wales the safest place in which to live and work and to visit.

Police Property Act Fund

PACT Trustees continue to manage the Police Property Act Fund on behalf of the Police and Crime Commissioner.

The Police Property Act Fund is made up of monies received by the police from the sale of found property and from property which is confiscated by order of the courts and then sold. The main aim of the fund is to support local projects undertaken by voluntary/charitable organisations that solely benefit the communities of North Wales.

Our Small Grant Fund and Main Grant continue to be a mainstay of our funding. Despite the pandemic PACT was able to support many projects with our Neighbourhood Policing Teams which you can see listed in the appendix. The Small Grant Fund continues to be extremely popular with our Neighbourhood Policing Teams. The fund, which allows officers to apply for grants of up to £250, is now in its 22nd year and provides a simple yet effective tool for community engagement.



PACT continues to receive sponsorship from CGI UK Ltd to support our Small Grant Fund, enabling PCSOs to get involved with community projects that help to support the Police and Crime Plan. We are grateful to Phillippa Proctor and her team at CGI for their continued support.

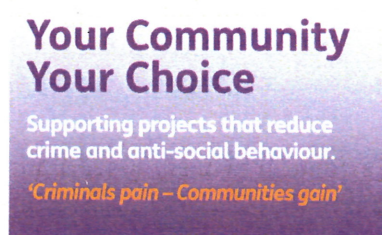

'Your Community, Your Choice' – Strengthening Resilient Communities



This year's 'Your Community Your Choice' saw over 32,000 votes being cast in support of projects across North Wales by members of the public.

Three organisations in each county were successful and were presented with their cheques in February 2022 at a virtual ceremony hosted by Police and Crime Commissioner, Andy Dunbobbin, Assistant Chief Constable Chris Allsopp and Ashley Rogers Chair of the North Wales Police and Community Trust.

Your Community Your Choice encourages community groups to apply for funding that help to support existing and new innovative projects that address crime and anti-social behavior by working in effective partnership and help build resilient communities.

Applicants were encouraged to work closely with their Neighbourhood Policing Teams to develop their proposals, and take ownership of local issues.

As usual applicants were expected to have due consideration for the Police and Crime Plan for North Wales and ensure their projects supported the Plan in their area and support the continuing theme of 'Strengthening Resilient Communities' encouraging applications that address current issues including youth engagement around county lines and knife crime, and supporting vulnerable, and isolated residents in our communities.

The ninth year of Your Community Your Choice saw 34 applications received totalling £71,639. Twenty-eight of these applications went forward for the public vote, following initial assessment procedures with over 15,000 votes received from the general public. Twenty-one projects received funding – three in each county plus three projects that worked across North Wales - with grants totalling £58,750.00

Crimebeat Activity 2021/22



This year saw an upturn in Crimebeat activity and many local youth groups were able to carry out projects in between periods of lockdown and in accordance with government covid guidelines. Many of these projects together with the work of local volunteers were celebrated at the annual High Sheriff Awards – the first since 2019.

In Gwynedd High Sheriff Gwyn Owen welcomed guests to the Hugh Owen Hall, Bangor University to celebrate some of the fantastic work that is being done in communities across Gwynedd and Anglesey.

Amongst those being recognised were Tir Dewi for their inspirational work to support farming and rural communities; the crew of the Moelfre Lifeboat; Galeri Creative Team for their community work in Caernarfon and beyond; Gisda for their work to support disadvantaged young people; and Gwynedd Youth Service for their work with young people.

A highlight of the evening was the presentation of the annual Crimebeat Project of the Year Award which this year went to Hwb Westend Hub – an initiative of Academi Westend in



Bangor. Working with young people the Hwb created a Street Art project during schools' holidays and worked with professional artist Any Birch, also known as Dime One, to create a street art graffiti mural depicting the work of young people in the area.



Another Crimebeat project to be recognised was the inaugural Primary Schools Internet Safety Poster Competition devised by PC Dewi Owen and PC Nick Hawe of North Wales Police. The competition saw over 570 primary school pupils submit posters to the competition. The overall winner across North Wales was Eva Lloyd-Wright from Ysgol Edern, Pwllheli. The High Sheriff was delighted to celebrate the work of PC Owen and PC Hawe to help keep our young people safe on the internet.

Over in Clwyd, High Sheriff Steve Thomas welcomed winners and guests to the Wings Club at Airbus UK in Broughton.

Nominations for a High Sheriff of Clwyd Award had been received from County Voluntary Services in Conwy, Denbighshire, Wrexham and Flintshire. There were many fantastic examples of how people throughout Clwyd had stepped up to volunteer in response to the

Covid-19 pandemic, including delivering meals to older or vulnerable people, addressing isolation and the important role that the volunteers played as part of the vaccination roll out.

High Sheriff Steve Thomas told the audience at the Awards: "Volunteers make a huge difference to our communities and I am honoured to have the opportunity to recognise everyone this evening"

The High Sheriff gave special thanks to Ann Woods, Chief Officer Flintshire Local Voluntary Council and her team who helped organise this year's Awards.

The highlight of the evening was the award to the Crimebeat Project of the Year which was awarded to pupils of Ysgol Estyn in Hope, Flintshire. Over the past twelve months pupils from the school worked with project leader Angela Done and Headteacher, Gareth Jones, to create a relaxation and mindfulness garden on school grounds to help them through the difficult times that we have all been through. High Sheriff, Steve Thomas, visited the school last year and was extremely impressed with their work and enthusiasm and was delighted to present them with their award.

Both High Sheriffs also took pleasure in recognising the work of their own High Sheriff Police Cadets:

- In Clwyd VPC Jaydon Parry and VPC Jack Taylor.
- And In Gwynedd VPC Sophie Roberts and VPC Bethan Evans

OP BANG (Be A Nice Guy) 2021



Together with North Wales Police and the Arson Reduction Team PACT has once again joined forces to ask people to 'Be a Nice Guy' with grants available through Operation BANG to support local initiatives that address deliberate fire-setting and anti-social behaviour over the Halloween and Bonfire period.

By working with key partners such as the North Wales Fire and Rescue Service, Community Safety Partnerships and local authorities, we are able to promote key messages through the 'Be a Nice Guy' initiative.

It has been identified that this approach, along with targeted diversionary activities which engage young people in fun and entertaining events, can be very effective in ensuring that everyone can enjoy themselves safely.

Notes to the Accounts

1. Accounting Policies

The principal accounting policies are summarised below. The accounting policies have been applied consistently throughout the year and in the preceding year.

a) Basis of Accounting

The accounts are drawn up on an accruals basis and in accordance with *Statement of Recommended Practice: Accounting and Reporting by Charities*, issued in March 2005.

b) Fund Accounting

- Unrestricted Funds are available for use at the discretion of the Trustees in furtherance of the general objectives of the charity.
- Restricted Funds are subject to restrictions on their expenditure imposed by the donor.

c) Incoming resources

All incoming resources are included in the statement of financial activities when the charity is entitled to the income and the amount can be quantified with reasonable accuracy. The following specific policies are applied to particular categories of income:

- Voluntary income is received by way of grants, donations and gifts and is included in full in the Statement of Financial Activities when receivable. Grants, where entitlement is not conditional on the delivery of a specific performance by the charity, are recognised when the charity becomes unconditionally entitled to the grant.
- Donated services and facilities are included at the value to the charity where this can be quantified.
- Investment income is included when receivable.
- Incoming resources from grants, where related to performance and specific deliverables, are accounted for as the charity earns the right to consideration by its performance.

d) Resources expended

Expenditure is recognised on an accrual basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered, and is reported as part of the expenditure to which it relates:

- Charitable expenditure comprises those costs incurred by the charity in the delivery of its activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.
- Governance costs include those costs associated with meeting the constitutional and statutory requirements of the charity and include the independent examination fees and costs linked to the strategic management of the charity.

- All costs are allocated between the expenditure categories of the SoFA on a basis designed to reflect the use of the resource. Costs relating to a particular activity are allocated directly, others are apportioned on an appropriate basis e.g. floor area.

2. Employees' remuneration

No employees were paid by the trust during the period. The services of a Project Manager/Crimebeat Co-ordinator were donated by North Wales Police. This cost is included in the statement of financial activities.

3. Trustees remuneration and expenses

None of the Trustees, nor any connected persons, received any remuneration during the period.

No reimbursements of Trustees expenses, or expenses of any other connected persons, were made during the period.
